REGULATIONS

The final text of these Supplementary Regulations shall be the English version, which shall be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 1 - Organisation

The Competition, which has the status of an International Competition, shall be run in conformity with:

- the International Sporting Code ("the Code") and its Appendices,

- the National Sporting Code where applicable,

- the official FIA Bulletins,

- the General Prescriptions applicable to International Hill Climb Competitions,

- the Sporting Regulations of the FIA CEZ and its Appendices, and

- these Supplementary Regulations.

c) Any Driver must mandatorily complete at least one practice heat and be credited with a practice time in order to be allowed to start the race. Special cases shall be submitted to the stewards.

d) Driver classifications shall be established by combining the times of each Driver's two best race heats.

Licence requirements:

<u>Category 1 Drivers:</u> Car driving licence and minimum National Licence (ND-R).

<u>Category 2 Drivers:</u> Car driving licence and Grade C International Licence (ITC-R).

In order to be taken into consideration, the entry form, duly dated and signed by the Driver and the Competitor, must be sent to the organiser before the closing date.

Rejections, Withdrawals:

In the event that an entry is rejected or the Competition is cancelled, the entry fees shall be reimbursed in full.

In case of withdrawal for reasons of Force Majeure (no-show for administrative checking and scrutineering) after the publication of the entry list, 50% of the base entry fees shall be reimbursed to the Competitor(s), subject to receipt of a written request.

Article 3 - Eligible cars - Groups and Categories

Cars will be admitted to the Competition in accordance with the regulations of the 2023 FIA CEZ Historic Hill Climb Championship.

At the scrutineering for each event a valid Historic Technical Passport (HTP) from FIA or a Zone member

ASN, comparable to the FIA-HTP, must be provided by the competitor for the car entered (other national car passes or documents are not accepted for this Championship); Every entry form for an event must be accompanied by a photocopy of the first page of this HTP.

3.3 Cars will be divided into the following categories (according to 2023 FIA CEZ Historic Hill Climb Championship):

Article 4 - Obligations of Participants

Competition numbers:

The organiser shall provide each participant with at least two sets of Competition numbers. A set of Competition numbers must be clearly displayed on both sides of the car throughout the Competition.

An additional set of Competition numbers (maximum height 15 cm) must be placed on the right side of the windscreen (or, if the car has no windscreen, on a forward-facing part of the car) and on the left side of the rear window.

Cars without their correct Competition numbers shall not be allowed to take the start.

Advertising:

The organiser has made the following advertising arrangements:

- mandatory (starting number) - arrangement in accordance with Appendix 2 or 2a of these Regulations,

- additional (reduced entry fee) - arrangement according to Appendix No. 2 or 2a to these regulations.

Article 6 - Insurance

In accordance with legal requirements, the organiser has taken out one or more insurance policies against the following risks:

- Third Party Insurance in the amount of PLN 10.000.000 (~ \in 2.222.000) for the event.

- Other: PLN 20.000 (~ \in 4 440) - Accident insurance - coverage in the event of permanent damage to the health.

The organiser's third party insurance is valid for the entire duration of the Competition, not only during official practice and race heats but also for travelling from the parking area to the course of the Competition and back.

Article 7 - Protests and appeals

Protest fee: €350.

International appeal fee (FIA): €3000.

Any protest must be lodged in accordance with the prescriptions of the Code. Protests must be made in writing and given to the clerk of the course or to his assistant, or in their absence to a steward, accompanied by the requisite protest fees.

If the protest requires the dismantling and reassembly of various parts of a car, the claimant must also pay a deposit which shall be set by the stewards.

A breakdown of the protest deposit fees if dismantling is required must be published on the official notice board or be available upon request from the organiser.

Competitors have the right to appeal against the decision of the Stewards, in accordance with Art. 15.1 - 15.4 of the FIA Code.

Article 8 - Podium, Prizes and Awards

8.1 Trophies

The classifications shall be established and shall entail the distribution by the organiser of awards as follows:

8.2. It is the duty of every competitor/driver taking part in the competition to participate in the awards ceremony.

8.3. It is also the responsibility of each competitor/driver to ensure a dignified setting for the closing ceremony of the competition through proper behavior of the competitor/driver and his team members, personal participation in the award ceremony and acceding to the award ceremony in the driver's outfit, i.e. in a zipped overall and footwear provided for by the regulations for motor sports.

8.4. Each identified unjustified violation of the rules by the competitor or the driver to comply with the obligations set out (art. 22.6 GSMP Regulations) will be treated as unsportsmanlike conduct and, at the request of the Clerk of the Course by the decision of the Stewards, a penalty will be imposed in accordance with point art. 22.10 GSMP Regulations.

Article 9 - Additional provisions by the organiser

9.1 In special and justified cases the organiser may allow additional administrative checks and scrutineering after the hours set for them, with a payment of an additional fee 300 PLN (ϵ 70).

9.2 The dates and place of subsequent stewards' meetings will be established at the first stewards' meeting and it will be published on the official notice board.

9.3 On the racetrack will be installed one chicane. Any breakage or wrong passage will be penalised by the Clerk of the Course following Juge of Fact's report and video footage analyses. The penalty for breakage is 1 second. Any other deviations will be penalised by the Panel of Stewards.

9.4 During the whole time of the Competition, inside the Service Park the speed limit of 30 km/h will be applied. Furthermore, each established or





confirmed case of infringement by the competitor/driver or his personnel member, within the confines of the existing vehicle park, will be treated as an offense. A penalty may be imposed according to the Stewards' decision.

9.5 All the competitors undertake the use of protective sheet under the car to prevent from damage and pollution of ground petroleum-derived materials.

9.6 Each competitor is obliged to keep a fire extinguisher (min. 4 kg) within immediate reach of his park.

9.7 Each competitor/driver is obliged to care of proper setting of completion of the event through proper behaviour, personal participation in the award ceremony and receiving the award being clothed in sporting outfit, i.e. overalls buttoned up and shoes complying with the provisions of motorsport.

9.8 The entry to the race is the conclusion of a civil law contract with the organizer. It also means the consent of the competitor / driver for the processing of his personal data for purposes related to the organization of the above race, and the whole series of competitions in which the race is organized. This application also means consent to the publication of photographs containing competitor / driver image and his/her results on the PZM website as well as other websites of the organizers of the rounds of competition series under which the each competition is organized. A Competitor / Driver has the right to access his / her personal data, correct them and request to cease processing of these data. A request to cease processing of his/her personal data means resignation from participation in the competition.


